By Laws Review: The meeting began early in order to complete the review of the changes in the Bylaws by the Ad Hoc committee. Geralyn prepared the document and reviewed. Following is some discussion captured to the best of my ability.

Article IX, Sec 5, Line 35: Laura asked the meaning of "should be a member of a Group". Is it member of a Home Group or a meeting attendee? Mike defined Groups as any group on a list. There was discussion on the wording. The agreed upon wording is: Candidates should be participating in meetings in the area Intergroup serves as defined in Article II-Purpose.

Article XIII, Sobriety: Sec 1: Line 47: Change remaining members to Secretary and Members at Large(2 yrs). Add: Committee Chairs should have 1 year continuous sobriety.

## Trudi: Page 13 L24 questioned wording "tasks A-F"

Dick: Suggests Job Descriptions be separate documents rather than part of the Bylaws.

Trudi: Delete Job Descriptions and just have Article VIII Duties of Officers or make sure they are exactly alike.

Dick: Steering Committee assures that detailed job description, with both duties and qualifications, are maintained and republished regularly to membership.

Sec 6 will be Sec 2 of Article VIII: Can be found in NDIAA Job Description document.

Trudi questions if someone steps down from a position. After discussion of the election process, it was decided that Article XIX would replace the words "special election" with "refer to Article IX.

Discussion regarding Quorum required for election. Outcome: Quorum is onefifth of registered groups for NDIAA (Carolyn's maintained list). She will send the numbers to Steering Committee for review.

Interim election process for February 2023 with new process implemented 9/23.
By laws were approved by Steering Committee and motion made and approved to take revised Bylaws to Membership.
