Minutes from previous meeting: Motion to Accept- Seconded- Accepted. None opposed.

**Chair**: George M. - got in contact with archivist at the Area level and looking into what can be done to bring archive up to Northern DE. Probably can't get originals, but could get copies.

Attended Spring Breakfast - great success and wonderful speaker. Special thanks to Special Events Committee and all involved in the event.

**Vice Chair:** Dave O.- There is an issue with old taxes that the IRS says we still owe, and we can't find proof that we paid them. Steering voted to use some of the 1.5 extra months of prudent reserve to pay the overdue taxes.

SERVICE OPPORTUNITY: We still need volunteers at the Intergroup office on Wednesdays. Qualifications are on the NDIAA website.

Literature Committee now has a form for us to fill out to request the Literature Table be present at our events.

Question from Andrew about what is really "prudent reserve," i.e. is the \$5,000 inventory included in that amount? Jared F. says that the prudent reserve is cash on hand, not including the inventory. See Jared for specifics on the math.

**Treasurer Report:** Jared F.- Steering recommended that membership accept statements as presented - voted to approve statements, none opposed.

Problem with Paychex and Dec. payroll taxes: we can prove we paid the taxes to Paychex, but they have not given the taxes due to the IRS. We are discontinuing our contract with them due to these issues.

To prevent the \$502.38 overdue taxes from 2019 and 2021 from continuing to collect interest and fines, the steering committee voted to go ahead and pay the overdue tax. Jared will send a paper check to the IRS to pay them and will get receipt. Membership voted to approve action.

We are on track to meet our budget this year, per finance committee.

We are purchasing the online version of Quickbooks this month, and will include Quickbooks Assisted Payroll (to replace Paychex).

Finance Committee scheduled the literature inventory for May and will discuss how much we will allocate to buy the new plain language Big Books when they come available for sale. Literature budget will, then, need to be revised.
