### **Committee Reports:**

**Bridging the Gap:** Stas W.: - Not Present. Bob F. filled in. He spoke with Holly Dixon of MeadowWood Behavioral Health Hospital this past week. She stated that they are looking for additional people from the program to visit those that are transitioning out of the facilities in order to take them to AA meetings. Bridging the Gap serves those in prisons, jails and psychiatric institutions.

Also, the BTG committee is continuing to look for a female volunteer to fill the needs of the women coming out of the various regional institutions.

Maureen M.: - Stated that, on the women's side, the stipulation to have those coming into the facility undergo TB tests has been reinstated by Baylor Correctional Facility. She also said this is causing delays in taking meetings into Baylor.

Also, last Saturday's meeting as well as the Jan. 11, 2025 meeting has been cancelled by Baylor Correctional.

Jack B.: - Not Present. Maureen stated that the men's side is going well, and that Jack is looking to step back from the Corrections Committee and have someone step into this position.

**Finance:** Dick H. – Not Present. Refer to the Treasurer Report. George filled in with the Finance Committee continues to search for someone with a Certified Public Accounting background to fill this role for Intergroup. Please circulate this to your groups.

Secondly, the Steering Committee needs to approve the 2025 budget so that financial transactions can continue in the new year.

A member presented a minority opinion concerning the previous discussions at Intergroup meetings about the reduction in staff hours in the Intergroup office due to financial difficulties and felt there should be other cost-cutting measures applied before cutting staff. This member stated he was expressing the group's conscience of the group he's representing. He further stated a concern that the current accounting system wasn't reflecting an accurate picture of the total money received from various groups 7<sup>th</sup> Tradition contributions.

In response, the Treasurer assured him and the fellowship that, while there has been some confusion and difficulties in the transition from the desktop version of QuickBooks to the online version, Intergroup has overcome those challenges and the January 8, 2025 Financial Summary and Report and other financial reports issued previously do reflect accurate accounts.

**Institutional Commitments:** Tim W.: – Opened with thanking the fellowship for the service of attending the various commitments through the holidays. He also expressed the importance of showing up for these commitments to those in facilities. Refuge House will meet at 7PM moving forward.
